SELF DECLARATION

I _____ S/W/O Sh./ Smt. _____ Block _____
_____ District _____ solemnly declared that _____ I will obey the Rules/ Sub Rules and amended Rules from time to time of the Water Supply & Sanitation Department, Punjab.

I will arrange the necessary article as Froot, Stop Cork/required pipe at my own expenses.

I am ready to take water connection without meter and ready to pay bill of water charges Rs. 60/75 per month or which rate will be fixed by the Department.

I agree to pay all that expenses, if I take water connection through the Department. I will deposit water charges and departmental charges before the fixed date. If my water connection is disconnected due to non-deposit of charges, then I will liable to pay Rs. 100/- for disconnection charges and Rs. 100/- for reinstallation charges of water connection.

If any loss to any building or road or loss of the Department take places due to the leakage of any fitting in my personal line coming from the main line of Water Supply & Sanitation Department pertaining to my house, I will be responsible for that loss.

If any delay found by me to stop leakage at my line coming from the main line of Water Supply & Sanitation Department, the Department can repair that leakage on my expenses and I shall be liable to pay that expenses. I will not install any Pumping Set at my water connection. If I will violate it, then I will be liable to pay Rs. 500/- as fine. Department can impound Pumping Set.

If the pressure of water reduce due to any technical defect, I will not demand any compensation. If the supply of water is dropped due to any technical fault/burst of pipe line or due to power failure then I will not demand for any compensation.
